Trade Finance League Tables H2 2020

(25 August 2020 – Asia) This league table of trade finance market share in Asia covers the relative positioning of the top 19 providers for the Top 1,000 multinational corporations (MNCs) and large domestic/ regional corporates in the region. It covers a range of solutions including documentary trade, supply chain finance, structured trade finance and e-Trade solution.

Primary market share: Percentage of corporates that nominate each financial institution as their primary trade financier, also known as primary relationship share.

Primary wallet share: Average percentage of trade finance volume that corporates allocate to their primary provider.
